<ul style="list-style-type: none"> <li>• People instructed to stay at home</li> <li>• All services and facilities close</li> <li>• Rationing of supplies and requisitioning of facilities</li> <li>• Major reprioritisation of health services</li> </ul>	<ul style="list-style-type: none"> <li>• All community members instructed to stay indoors – for example no visitors to enter or exit town except health and service professionals</li> <li>• Food and essential supplies to be rationed and distributed to individual homes</li> <li>• Health services to coordinate and prioritise those most at risk</li> <li>• Potential use of overflow facilities – for example suitable venues to be identified until ambulance services can transfer the patient to hospital</li> </ul>	<ul style="list-style-type: none"> <li>• NSW Health Minister, Police, NSW Health, NSW Public Health Unit, LALC, Elders, PACC, ACLO, Security, Council Rangers</li> <li>• SES volunteers, FACS Intereach, VRA, Rotary.</li> <li>• NSW Health, Council, EOC, Functional Areas, FACS.</li> </ul>
