A Place Vision for Meadowbank

The NSW Government and the Greater Sydney Commission have released their new Place Vision and Master Plan for the Meadowbank Education and Employment Precinct.

Together, they provide a road map for a place-based approach to deliver an innovative precinct at Meadowbank, which will have education at its heart while also connecting students to training and employment opportunities with local industry and the surrounding community.

The Master Plan brings the Place Vision to life and will help coordinate new State infrastructure with other improvements in the local area, facilitating better outcomes for businesses and residents. Progress this quarter has stepped up, with three major milestones achieved to help realise brand new, purpose-built education facilities by 2022 and collaboration with industry.

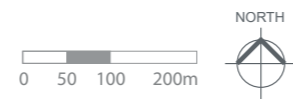
- The final Place Vision and Master Plan documents have been released and can be found at nsw.gov.au/meadowbankprecinct. They provide a project road map and identify areas for improved public spaces, green streets, transport and accessibility options and enhanced employment opportunities.
- The State Significant Development (SSD) applications for both the Schools and TAFE NSW's new Multi-Trades and Digital Technology Hub were fast tracked by the Department of Planning, Industry and Environment. Both applications have been assessed and approved.
- Main construction at the schools site commenced on 7 September 2020.

The Meadowbank Education and Employment Precinct Master Plan

The Master Plan for the Education and Employment Precinct has now been finalised and considers the area holistically, providing context for the new schools facilities and TAFE NSW Campus. It proposes new ideas for future projects including improving public spaces, streets, access to transport and local services. Students, workers, residents and visitors will benefit from improved pedestrian access, cycleway facilities and employment options.



- Investigate modifying streets into 'Living Streets' that prioritise pedestrian and cyclist movement
- Enhance connectivity with an overpass across Victoria Road and an underpass beneath the railway line
- Support walking to school by investigating opportunities for pedestrian safety upgrades such as footpath widening, improved intersections, reduced speed limits and/or shared zones
- Improve vehicle access and intersections around the precinct
- Explore opportunities for a shared pedestrian and cyclist route along the railway line with links to the stations, schools, TAFE and the existing cycle network
- Establish legible, welcoming, safe and accessible entries to the schools and TAFE sites
- Strengthen green infrastructure in the region including a blue link along the natural drainage corridor and new green open spaces
- Strengthen the accessibility and connectivity around the existing train station centres
- Support intensification of employment land as a significant asset for local jobs. Explore opportunities for revitalisation and/or community spaces within the heritage listed Sydney Water Site
