

Classic Vehicle Declaration

- This form must be submitted as an original. Photocopies will not be accepted.
- The Applicant is responsible for the vehicle to be suitable for safe use until the expiry date of the registration.
- An Inspection must be presented to Establish or Renew the registration. If required, the Compliance Certificate must also be presented.
- The Applicant must be a financial member of a club affiliated with an Approved Organisation.
- The vehicle must be 30 years of age or older and meet eligibility requirements of the Classic Vehicle Scheme.
- The Gross Vehicle Mass (GVM) is only required where it is allocated by the vehicle manufacturer.
