

Privacy Management Annual Report 2018-19

Part 1. Compliance activities

The Far West Local Health District Privacy Contact Officer has continued to provide legislative, policy and compliance support/advice to health service staff, particularly in relation to access to, and disclosure of personal health information and electronic medical records.

The Privacy Contact Officer actively participates in privacy networking and professional development, and attended privacy information and network sessions during 2018-19 which were facilitated by the NSW Ministry of Health Regulation and Compliance Unit.

Privacy complaints

Privacy complaints may be managed in accordance with a range of policies. Those policies include the NSW Health Privacy Internal Review Guidelines, the NSW Health Complaint Management Policy and related information management policies.

Where an application for internal review is made, efforts are made to demonstrate to an applicant the difference between the processes, to enable an informed choice about the management of their complaint.

Part 2. Internal review

The *Privacy and Personal Information Protection Act* 1998 provides a formalised structure for managing privacy complaints relating to this Act and to the *Health Records and Information Privacy Act* 2002. This process is known as 'internal review'.

For the 2018/19 reporting year, Far West Local Health District only received one privacy internal review matter which was *carried over* from 2017-18 reporting period.

Details:

The applicant lodged a complaint alleging a breach of privacy. The agency undertook an investigation and concluded that no privacy breach had occurred. The internal review was finalised in the 2018/19 reporting period.

Further review in the NSW Civil and Administrative Tribunal (NCAT):

The applicant sought review by NCAT - YES.

To date the matter has not resolved and is next listed for a Directions Hearing. The matter remains ongoing.
