# Applicant Information Package

I his information package should be read prior to submitting an application.

The NSW Health Enrolled Nurse (EN) Scholarships are offered by the Nursing and Midwifery Office, NSW Ministry of Health in partnership with Registered Training Organisations (RTOs). The scholarship includes course costs for HLT54121 Diploma of Nursing and an offer of employment as an EN within a NSW Health facility (subject to standard recruitment processes).

#### **Key information**

- Scholarship recipients will commence the HLT54121 Diploma of Nursing program from March 2023 (start dates vary between campuses).
- Scholarship recipients are required to pay the **student fee** component of the Diploma. If applicants are eligible for fee-free training under the Skilling for Recovery Initiative, they will not be required to pay the student fee and will not be eligible for reimbursement of course costs from NSW Health.
- After completing the Diploma of Nursing and successfully progressing through standard registration and recruitment processes, recipients will be offered employment as an EN with NSW Health. This may be on a full-time, part-time, or casual basis.
- Once recipients have been employed for a minimum of 12 months working at least 2 shifts per week, they are eligible for reimbursement of the student fee paid unless student is eligible for fee-free training.
- Applicants choose the location where they will study and undertake clinical placements.
- Gaining a scholarship is a competitive process and includes an online application, literacy, language, and numeracy (LLN) testing, and an interview. All eligibility criteria must be evidenced prior to scholarships being awarded.

#### Who can apply?

If you want to become an EN and you meet the eligibility criteria below, we encourage you to apply for an EN Scholarship.

#### Criteria

**You are an Australian citizen or permanent resident.** New Zealand citizens residing in Australia with a Special Category Visa are considered to be permanent residents (evidence is required)

#### You reside in NSW

You meet the English language skill standard to gain registration as an EN in Australia, as specified by the Nursing and Midwifery Board of Australia (NMBA): see Appendix A for further information and evidence required

You have completed the NSW Higher School Certificate (or equivalent), or a Certificate III (AQF Level 3) qualification (or equivalent)

You are prepared to work within NSW Health as an EN on graduation, and to comply with NSW Health employment and immunisation policies

You understand the EN <u>role</u> and are able to meet the physical demands

You are prepared to meet the mandatory requirements for <u>police check, code of conduct, immunisations</u> (including 3 doses of a COVID Vaccine) as per the <u>HETI Website</u>.

You are not currently enrolled in a Diploma of Nursing program

You have not previously qualified as an EN or a Registered Nurse

You have not previously received a NSW Health EN Scholarship

# Scholarship conditions

#### Fees

Scholarship recipients receive a subsidised position in the **HLT54121 Diploma of Nursing** program. The cost to the scholarship recipient is the **student fee** component (approximately \$5,000) which will be **reimbursed in full** to the scholarship recipient once the following requirements are met:

- Successfully completes the Diploma of Nursing
- Achieves registration as an EN with the Nursing and Midwifery Board of Australia
- Completes a minimum of 12 months of employment as an EN in a NSW public health facility (working a minimum of 2 shifts per week).

The **student fee** component is payable on commencement of the Diploma. This fee is approximately \$5,000 however the <u>student fee</u> <u>varies for individual circumstances</u>: reductions and exemptions may apply. <u>VET Student Loans</u> may be accessed to cover/defer this cost. You must be an Australian citizen or permanent humanitarian visa holder to be eligible for VET Student Loans.

If applicants are eligible for fee-free training under the Skilling for Recovery Initiative, they will not be reimbursed course costs from NSW Health.

#### **Employment**

Scholarship recipients will be offered employment in a NSW Health facility following successful completion of the Diploma and registration as an EN, subject to standard recruitment processes. This offer is valid for two years from the course commencement date. Employment may be on a full-time, part-time, or casual basis (minimum 2 shifts per week).

#### **Other costs**

You may be required to purchase textbooks or specific uniform requirements during your study and clinical placements. These items will be at your expense.

# Key scholarship dates



## Selection criteria

As part of the application, you are required to write up to 240 words for each question below.

- How do you use your effective communication skills, both written and verbal?
- What do you understand about working in a team?
- How do you plan your work so tasks can be completed in set time frames?

We suggest you **prepare your responses prior to completing your application** so they can be copied and pasted into your online application. NSW Health is committed to growing our Aboriginal and Torres Strait Islander workforce. Aboriginal and Torres Strait Islander people are strongly encouraged to apply.

# Application and selection process

- Apply online via the link on the <u>Nursing and</u> <u>Midwifery Office website</u>. Applications open
   12 midday 9 January 2023 and close at middnight
   12 February 2023. The online application requires:
  - a. your personal and contact information
  - b. your responses to the 3 selection criteria:
    - i. Communication skills
    - ii. Team work
    - iii. Time management (see Selection Criteria for further information)
  - c. your academic qualifications
  - d. your schooling/education history
  - e. your work/industry/community experience
  - f. your preferred location for study and clinical placements.
- 2. **Applications are assessed for eligibility** by the Nursing and Midwifery Office, NSW Ministry of Health. Ineligible/incomplete applications will be notified unsuccessful prior to the end February 2023.
- 3. Eligible applications are referred to the relevant education provider for further assessment. If eligible, you will be invited to attend the RTO campus for literacy, language, and numeracy testing (an assessment of your reading, comprehension, and basic mathematical skills), conducted from late February –late March 2023. You will need to take all of your supporting documents for sighting by the education provider as evidence of your eligibility (for further information see Application Requirements).

- 4. If your literacy, language, and numeracy assessment results are favourable and you have provided all evidence required to prove your eligibility, you will **proceed to an interview**. This may be conducted on the same day. The interview panel consists of up to 3 people and will include representatives from the education provider and the linked Local Health District/Specialty Network.
- 5. **The education provider will advise you of the outcome** by email by end of March/early April 2023. If you are not offered a scholarship position, there may be other ways you can enter nursing or access the Diploma. The education providers can advise you on alternate pathways.
- 6. If you are offered a scholarship, it must be accepted by the due date stated in your letter. Failure to do so will result in the offer being withdrawn.

# Study and clinical placement locations

Applicants are asked to select their preferred location to study. Each campus is linked with one or more Local Health District/Specialty Networks (LHD/SN) in the local area.

Students are required to attend face-to-face classes with the education provider and to complete a minimum of 400 clinical placement hours within the linked LHD/SN as part of the Diploma.

The offer of employment on completion of the Diploma is within the linked LHD/SN. For information on specific LHD/SNs, please click <u>here</u>.

\* If the name on any supporting documents differs from your application, evidence of name change must be provided, for example, marriage, divorce, or change of name certificate.

### **Unique Student Identifier**

If you do not already have a <u>Unique Student Identifier</u> (USI), you must apply for one prior to enrolment in the Diploma of Nursing. Your USI links to your online training records. You will need to provide your USI to your RTO on enrolment.

### **Immunisations**

NSW Health facilities will not accept students to clinical placement if they are not immunised for a range of infectious diseases. Your RTO will provide detailed information regarding <u>NSW Health</u> <u>Occupation assessment</u>, screening and vaccination against specified infectious diseases.

### **Personal considerations**

Applicants should be confident in their ability to meet the physical and emotional demands of being an <u>Enrolled Nurse</u>, which includes <u>mental health nursing</u>. Applicants that are invited for interview will be required to declare any health condition/s (physical or mental) which might prevent them performing the demands of the job.

### Registration

Diploma of Nursing students are required to be registered with the Nursing and Midwifery Board of Australia. Student registration is undertaken following enrolment. There is no cost involved.

# Other requirements before you apply:

### **Important points**

- Review the application requirements to ensure you meet the criteria. All supporting documents/ evidence must be available for presentation to the RTO: if you cannot demonstrate you meet the eligibility criteria, your application will not be progressed.
- Once commenced, your online application must be completed within 60 minutes. The system is designed to time-out at 60 minutes. If this occurs, all input is lost and a new application is required.
- Applications are unable to be saved or accessed again. You will receive a confirmation email with a reference number that you can use to communicate any issues.
- We advise that you use a desktop or laptop computer to complete the online application. The application is optimised for Google Chrome and IE10+.
- Apply online via the Online Application link on the Nursing and Midwifery Office website 12 midday 9 January 2022 – midnight 12 February 2022.



#### **Appendix A**

#### English Language Skill requirements for Scholarship Applicants

Applicants must be able to provide formal evidence of English language skills prior to commencing the Diploma. This is to ensure compliance with the Nursing and Midwifery Board of Australia's (NMBA) current English Language Skills standard Skills standard and policy for registration as an Enrolled Nurse. Please read the links, consider the flowchart questions below, and ensure you have the relevant documented evidence available to support your English language skill (as below).



*Primary language* means the language primarily used for reading, writing, listening, and speaking and the language you know best and are most comfortable with

\*Recognised countries: Australia, Canada, New Zealand, Republic of Ireland, South Africa, United Kingdom, and United States of America.

#### Evidence required to demonstrate your English Language Skill

### Box 1

Based on your answers to the questions on the previous page, to demonstrate English Language Skill you are required to:

- 1. Detail your education history within the scholarship application. **If English is your primary language**, you will need to demonstrate that you have attended and satisfactorily completed at least six years of primary and secondary education taught and assessed in English in one of the recognised countries\*, including at least two years between years 7 and 12.
- 2. Take your documented evidence to support your educational history to TAFE/RTO when you are invited for further assessment and eligibility checks. Accepted evidence includes formal documentation of Record of School Achievement, HSC or equivalent, academic transcript/statement of attainment, award certificate, school reports, or statutory declaration.

## Box 2

Based on your answers to the questions on the previous page, you will need to submit your results from an English language test recognised by the NMBA to demonstrate that you will meet the NMBA's English Language Skills standard for registration as an Enrolled Nurse. Your results are needed as part of your application.

#### English language tests recognised by NMBA and required minimum scores

#### a) International English Language Testing System (IELTS) Academic module

A minimum overall score of 7 and a minimum score of 7 in each of the four components (listening, reading, writing and speaking). NOTE: test results are accepted from i) one test sitting, or ii) a maximum of two test sittings in a six month period only if you achieve a minimum overall score of 7 in each sitting, and you achieve a minimum score of 7 in each component across the two sittings, and no score in any component of the test is below 6.5. **OR** 

#### b) Occupational English Language Test (OET)

A minimum score of B in each of the 4 components (listening, reading, writing and speaking). NOTE: test results are accepted from i) one test sitting, or ii) a maximum of two test sittings in a six month period only if you are tested in all four components in each sitting, and you achieve a minimum score of B in each component across the two sittings, and no score in any component of the test is below C. **OR** 

#### c) Pearson Test of English Academic (PTE Academic)

A minimum overall score of 65 and a minimum score of 65 in each of the four communicative skills (listening, reading, writing and speaking). NOTE: test results are accepted from i) one test sitting, or ii) a maximum of two test sittings in a six month period only if a minimum overall score of 65 is achieved in each sitting, and you achieve a minimum score of 65 in each of the communicative skills across the two sittings, and no score in any of the communicative skills is below 58. **OR** 

#### d) Test of English as a Foreign Language internet-based test (TOEFL-IBT)

A minimum total score of 94 and the following minimum score in each section: 24 for listening, 24 for reading, 27 for writing, and 23 for speaking. NOTE: test results are accepted from i) one test sitting, or ii) a maximum of two test sittings in a six month period only if a minimum total score of 94 is achieved in each sitting, and you achieve a minimum score of 24 for listening, 24 for reading, 27 for writing and 23 for speaking across the two sittings, and no score in any of the sections is below 20 for listening, 19 for reading, 24 for writing, and 20 for speaking.

PLEASE NOTE If your English language test results were obtained prior to two years before the date you lodge your application for registration as an EN, you may be required by the NMBA to re sit the test at the time of registration.

For further information, refer to the English Language skills registration standard fact sheet. The above evidence is also required when applying to the NMBA for registration at the completion of your Diploma. Registrants are required to declare that all information provided during the application process is true and accurate. A false statement may be grounds to refuse registration.

In July 2020 the Australian Nursing and Midwifery Accreditation Council updated advice for English language skills requirements for students enrolling in entry to practice nursing education programs. **Diploma of Nursing program applicants are not able to enter the program via the English Language Skills (ELS) extended education pathway**. Students entering Diploma of Nursing programs need to declare that English is their primary language or provide a valid ELS test result. The purpose of the standard criterion relating to English language is that students have an appropriate English language skills level at the start of the program i.e. before they undertake professional experience placement.
