# Government Information (Public Access) Act 2009 ANNUAL REPORT

#### 1. Review of proactive release program – Clause 7(a)

Under section 7 of the GIPA Act, agencies must review their programs for the release of government information to identify the kinds of information that can be made publicly available. This review must be undertaken at least once every 12 months.

Murrumbidgee Local Health District's program for the proactive release of information involves a review of information requested via informal access and formal access channels. This includes ongoing or repeated requests for information and working with the executive team to identify information that can be released proactively. The District also reviews the Disclosure Log and websites of other agencies to see the type of information they release proactively.
