1. OPENING AND ACKNOWLEDGEMENT OF COUNTRY

The Chair opened the meeting with Acknowledgement to Country and apologies were noted. Members were advised that the purpose of the month's Board members only meeting is to focus on current key issues, allowing more time for discussion.

2. DECLARATION OF CONFLICTS OF INTEREST

The Chair asked members to advise any changes to the conflicts of interest register. The Chair notified that he is now Chair of Industry Super Australia.

3. MINUTES OF PREVIOUS MINUTES

Minutes of the meeting on Wednesday, 17 May 2023 were accepted as a true and accurate record of the meeting.

4. CHAIRMAN'S REPORT

Chief Executive Retirement

The Chair reported that the Chief Executive has provided notice that she will be retiring as of 1 September 2023. Members were advised that the Chair and Secretary, NSW Health will be releasing a joint statement to all staff of Nepean Blue Mountains Local Health District after the Board meeting. The Chair highlighted the Chief Executive's career as transformative and instrumental leadership during such times as COVID-19, climate change and continuing to work tirelessly on business as usual. The Chair thanked the Chief Executive on behalf of the Board and staff of Nepean Blue Mountains Local Health District for the past 12 years of service. Members held extensive discussion on the District's accomplishments during the Chief Executive's tenure.

Future Funding

The Chair brought attention to the District Budget and the challenging times ahead. Members noted that there is an underlying deficit for NBMLHD, which makes the challenges faced by the system generally more significant. Prof Seppelt noted the gap between the beds in the Redevelopment business case and those currently available at the completion of Stage 1.

Meeting with Local MPs

The Chair reported on meetings held with Ms Karen McKeown, Member for Penrith and Ms Trish Doyle, Member for the Blue Mountains. The Chair highlighted the incoming government's commitment of \$25M for planning and urgent repairs for BMDAMH. Members held discussion on the much-needed Nepean Cancer and Wellness Centre which is now estimated at a cost of \$350-380M. The Chair reported that a meeting has been scheduled with the Hon. Prue Car, Deputy Premier and Member for Londonderry.

NBMLHD Capacity

Members held discussion on funding, staffing and how staff are working toward a common goal. It was noted that overall, the District relies on Nepean as the main hospital and that there is very limited capacity to transfer patients to other facilities to relieve pressure points. Members noted that other Districts have greater advantage with the flow of patients.

NBMLHD Board vacancies

The Chair reported on the number of vacancies for the NBMLHD Board. Members were advised that the Chair will be writing to Minister Park and expressing his concern and identifying potential new Board members.



The Chair called for nominations to the position of Deputy Chair. Members unanimously recommended Dr Nhi Nguyen to be appointed as Deputy Chair, NBMLHD Board.

5. CHIEF EXECUTIVE REPORT

Members noted the Chief Executive's report for the month of July 2023. The Chief Executive advised that the report will be taken as read and highlighted the following:

Healthy People & Communities

Somerset Cottage Early Childhood Education and Care Centre Disinvestment

The Chief Executive reported that Somerset Cottage transitioned to Penrith City Council on 26 June 2023.

Hawkesbury District Health Service - St John of God Healthcare

The Chief Executive provided an update on the ongoing negotiations with St John of God Healthcare.

Dr Rombola declared he is a member of the Hawkesbury Medical Advisory Council

Blue Mountains Hospital and Community Health Clinical Services Plan (CSP)

Members noted that the Planning and Strategic Office are continuing to work to finalise the CSP for Blue Mountains and Community Health.

In June a series of consultation workshops and meetings were held with key stakeholders, including staff, community members and partner organisations including Blue Mountains City Council. The Blue Mountains Gazette attended and reported on two of the community workshops (Lawson and Katoomba). Members noted that Ms Trish Doyle, local member for Blue Mountains attended the Lawson workshop.

Exceptional Patient and Consumer Experiences and Outcomes

System capacity

The Chief Executive reported on the NSW Health capacity over the winter months. Members noted that the system has been stretched across the State. Members were advised of NBMLHD activity and that all Districts are in a similar position.

Long COVID

The Chief Executive reported that Primary Care and Community Health have received a budget supplementation for the establishment of a long COVID service at NBMLHD. The concept is that the service is primary care based with access to LHD services as required including virtual care and Hospital in the Home.



Talented, Happy and Engaged Workforce

Dr Faraz Pathan

The Chief Executive reported that Dr Faraz Pathan, Director Cardiovascular Imaging and Heart Research, was a speaker at the inaugural TEDxKatoomba event in the Blue Mountains.

Members were advised that Dr Pathan was selected from over 100 local submissions for his passion for improving lives and wellbeing of Australia's workforce to combat an unwavering heart disease epidemic.

Junior Medical Officer (JMO) Recruitment

The JMO Recruitment team continue preparations for the 2024 JMO Annual Medical Recruitment campaign. Advertisements for 270FTE (across 65 positions) are active. An additional 150FTE+ will be allocated to NBMLHD by centralised panels, College recommendations and intern allocation processes.

Psychosocial Hazard Update

The Chief Executive reported that NSW Ministry of Health have been leading discussions relating to Psychosocial health for staff. The Ministry advise they are finalising the Mental Health and Wellbeing Framework and have engaged external expertise to assist development and delivery of an action plan and identify the strategies/resources to support the Framework. The Framework will be launched statewide during July.

The Chief Executive highlighted that the proposed future governance includes the following:

- Board Subcommittees are aligned to the strategic outcomes of Future Health and the NBMLHD Strategic Plan.
- The current Integrated Care Joint Board Committee (NBMLHD and Nepean Blue Mountains Primary Health Network) is replaced by a separate 'partnerships committee' with the PHN and other partner organisations.
- Each Board Subcommittee will be responsible for monitoring relevant Key Performance Indicators and/or deliverables from the District Services Agreement with NSW Ministry of Health.
- KPIs and deliverables are being mapped to governance committees as part of the accreditation actions.

The Chief Executive reported that the proposal will ensure greater transparency for staff within NBMLHD. Members held extensive discussion and requested a session be held with Board Sub Committee Chairs and District Executive to map and ensure that the proposed governance structure aligns.
