A NSW Single Status Certificate may be required if you intend to be married overseas or if you are returning to your country of residence to be married. You may use the Single Status Certificate to show that you are not currently married in NSW.

Certificate entitlement

If you are applying for your own certificate, you must provide:

Three forms of your own ID (see below)

If you are applying for a certificate on behalf of another person, you must provide:

- A Letter of Authority (available at: www.nsw.gov.au/bdm) giving permission from the person named on the certificate. Please include their address, phone number and signature.
- Three forms of ID from the person giving permission (see below).
- Three forms of your own ID (see below).

What is a Single Status Search?

This search checks if you were legally married in NSW from the age of 16 to the present date. If you were previously married, the search starts from the end of that marriage. If you arrived in Australia after you turned 16, and have not married, the search starts from your date of arrival. The certificate fee includes an initial 10-year search. For each decade or part thereof searched above this, an additional fee applies.

Identification (ID)

Please provide at least three forms of ID, one of each from categories 1, 2 and 3. If you are unable to provide ID from categories 1 and 2, you must still provide at least three forms of ID. At least two of these must be from category 3. All documents except foreign passports must be current.
