LIW01 - Geotech in HAMU15 work completed.

No scheduled or defined works of predicted Noise or Vibration impact have commenced.

The AA has attended 1 Environmental Sustainability, and 2 Environment & Planning meetings.

- *CEMP onboarding for JH engineers being completed (OOHW, HNIW process, CNVIS requirements).*
- *Haul road design to be finished in the next week, will be passed onto SOPA, via TTL landfill*

Upcoming works and discussion of risks

Staging activities are focused on enabling works for delivery of a public and active transport bridge across the Parramatta River, including the approaches between Melrose Park (northern) and Wentworth Point (southern).

Site establishment of Melrose Park delayed, now likely during March 2025.

Commencement of works anticipated, including Pre-construction minor works.

Vegetation clearly planned.

Wentworth Point compound is currently on-hold.

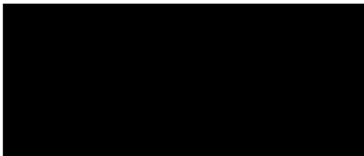
A1 Low Impact Work (Minor Activities) commencing, including:
