


STAFF	Our staff feel safe, engaged and well at work	Youth Justice will have the right recruitment and induction, ongoing training and development and support programs in place for staff and that Youth Justice responds well to incidents and risks.	
YOUNG PEOPLE	Young people in contact with Youth Justice feel safe and supported	Youth Justice will provide services that are trauma-informed, culturally sensitive and appropriate, and child safe; and that young people feel safe and supported and can fully engage.

- Feedback and complaints triage system in Centres establish in Acemena,
  Riverina, Baxter & Cobham (trial in progress: roll out from March 2021)
- Young people and YJNSW governance policy (February 2021).
- Integration of identified Voice2Action opportunities with current and future reforms and gap analysis
- Child Safe: Questionnaires analysis (commence 2021 then ongoing).
- Partner with OPS and Trans & Gender Diverse CJS Advisory Council to enhance staff resources, policies and training for working with LGBTQI+ clients
- Disability Action Plan projects (Commence 2021)

### WHAT DOES THIS MEAN?

### REOFFENDING

The number of young people who reoffend following a Youth Justice Conference, a custodial order, or a supervision order is reduced by 10% by 2022

Young people will receive the right programs and services to break the cycle of reoffending. By 2022, there will be 110 fewer young people reoffending annually

## ABORIGINAL YOUNG PEOPLE

The average daily number of Aboriginal young people in custody is reduced by 10% in 2022

Aboriginal young people will receive the right supports at the right time to ensure they do not end up in custody. By 2022, on an average day there will be 12 fewer Aboriginal young people in custody in NSW

## DOMESTIC FAMILY VIOLENCE

The number of juvenile domestic violence reoffenders each year is reduce by 25% by 2023 (Premier's Priority)

Youth Justice will provide appropriate supports and interventions to prevent young people from committing further DFV offences. 55 Fewer young people each year are charged with DFV reoffences by 2023



### **UNDERWAY AND ONGOING IN 2021**

Police Station

- Casework Review followed by implementation of a resource allocation model / framework. Collaborative Responsive Family and Adolescent Team (CRAFT) - Joint YJ/CS initiative - Burwood and Sydney YJCOs Dedicated Aboriginal Caseworker for Koori Bail Court duty (Parramatta YJCO). Collaborative practice project - joint YJ/CS initiative focussed on three areas of YJ practice to enhance outcomes for YP through collaborative practice (Newcastle YJCO). Nura Gamarada Cultural Learning Group (monthly) - Sydney YJCO. Implementation of a new Referral, Intake, Review and Exit process for Casework Support Program to standardise information given to providers, allow for better measurement of outcomes and improved data capacity, and systematically gather feedback from young people (currently being trialled). Evaluation of Rural Rehabilitation Program in Dubbo and Coffs Harbour, followed by business case to Government for ongoing funding beyond June 2022 (~\$3.5M/annum). A Place to Go (APTG) pilot @ the Children's Court in Parramatta and Penrith
- The Broadmeadow Children's Court Pilot (BCCP) multidisciplinary courtbased team provides targeted and holistic support to children and young people presenting at the Broadmeadow Children's Court in Newcastle.
- UNSW Program Evaluation will be delivered December 2020 and inform a business case to GOvernment for funding of APTG and BCCP beyond June 2021
- Name, Narrate, Navigate joint YJ/Newcastle University initiative delivering a DFV program to clients of Maitland, Muswellbrook, Tamworth (YJCOs).
- DFV Pilot involving a YJCW and Assistant Manager accessing specialised training, developing resources, raising awareness and developing partnerships with other agencies - Mid North Coast YJCO

### — DFV Strategy:

- NSW Health/DCJ Problematic and Harmful Sexual Behaviours (PHSB) Project
- YOA changes to enable DFV matters to be diverted to Youth Justice conferencing
- Dialectical Behaviour Therapy pilot at Reiby YJC, then train psychologists and JH staff in other centres
- Enhance CHART healthy relationships module to respond more effectively to DFV
- YJ contribution to development of DC Framework for CALD (DVDRT Recommendation 17) - commenced, ongoing into 2021



### **COMMENCING IN THE SHORT TERM (SOMETIME IN 2021)**

- Transition of Casework Support Program contracts (~\$5M/annum) onto Human Services Agreements and adaptation of KPIs to enhance outcomes for Aboriginal YP (from 1 July 2021)
- The sexennial Young People in Custody Health Survey a collaboration between YJNSW and the Justice Health and Forensic Mental Health Network. Previous surveys were in 2003, 2009 and 2015. Data collection from September to December 2021.

#### — Youth on Track:

- Interim reoffending Evaluation report and CBA (January 2021).
- Budget bid to extend 6 Youth on Track sites to June 2022 aligning contracts of all 7 sites and a further 12 months funding for all 7 sites to June 2023.
- Final Reoffending Evaluation report from BOCSAR and CBA

- ADVO, bail and court process understanding project through Digital Restart Fund - project to commence by mid-2021
- Development of a young person forced safety planning tool commencing 2021 following the completion of the evaluation of the What's Your Plan? initiative

- Short Term Remand Project 2021 program of works (TBC)
- Youth Frontiers Mentoring Program joint YJ/CAFS initiative (TBC)
- Dubbo Early Intervention Education Initiative joint YJ/Education/PCYC initiative
- ACCORD developing partnerships for enhancing community bail options for Aboriginal Young People (Gosford YJCO).
- Aboriginal Mentor Program Metro/Northern Directorate APO-led in partnership with Shine for Kids (TBC)
- Review of Frank Baxter Mentoring Program (~\$170I/annum) and development of options paper re the program's future Bail Assistance Line transition to the Bail and Accommodation Support Service (July 2021).
  - Implementation of **Young Offenders Act legislation changes** (approx September 2021)



### **COMMENCING IN THE LONGER TERM (2022 AND BEYOND)**

- Work with DCJ colleagues and Aboriginal Community Controlled
   Organisations to develop the capacity of ACCOs to contract with YJ to
   provide complementary casework support (social welfare) services for
   YJ clients into the future
- Youth on Track budget bid re statewide expansion of Youth on Track + commence state-wide expansion tender by 1 July 2022
- Alternatives to custody business case and implementation
