PREMIER'S VISIT TO LEBANON AND UNITED ARAB EMIRATES 12 – 18 MAY 2012

POST VISIT REPORT – <u>LEBANON PROGRAM</u>

MISSION PURPOSE

- To highlight the importance the NSW Government is placing on Lebanon as a valued friend and growing trading partner.
- To strengthen the cultural ties between the NSW Government and Lebanon, especially those forged during the recent Presidential visit.
- To achieve high level access to government leaders to reinforce the NSW Government's commitment to Lebanese-Australians.

MISSION DESCRIPTION

The Premier's delegation included three Members of Parliament of Lebanese heritage, as well as three representatives of the Lebanese-Australian community including the Islamic Council of NSW and the Lebanese Muslim Association.

It also included the Director-General of the Department of Premier and Cabinet and the Australian Ambassador to Lebanon.

The group represented the broad spectrum of Lebanese-Australians with extensive relationships in Lebanon.

Meetings were sought with the following:

- Political leadership at all levels of government;
- Leaders from the four major religions Maronite, Druze, Sunni and Shi'a.

- Destination NSW to explore tourism opportunities for Lebanon.

PREMIER'S VISIT TO LEBANON AND UNITED ARAB EMIRATES 12 – 18 MAY 2012

POST VISIT REPORT – <u>UAE PROGRAM</u>

MISSION PURPOSE

- Demonstrate the NSW Government's commitment to strengthening its export development and broader trade and investment relationships with the United Arab Emirates (UAE).
- Promote NSW capabilities in the areas of infrastructure/construction, financial services, education and manufactured food product exports.
- Reinforce to government, commercial and media audiences the strength of the NSW economy as Australia's largest State; support NSW's broad range of exporters of services and manufactured goods; and profile NSW breadth and range of NSW investment opportunities.
- Meet with key prospective and existing investors and importers of NSW products and services.
- Increase awareness of the NSW Government Business Office in the UAE and the services it provides to existing and new investors and trade partners in the region.

VISIT DESCRIPTION

Immediately following the Premier's community visit to Lebanon, the Premier conducted a busy three day visit to the UAE. This program comprised four government meetings, eight business meetings, eight targeted business events and two media interviews (refer to program summary below).

The two largest Emirates were visited: Abu Dhabi as it is the centre of government and UAE finance, and location of the NSW Trade & Investment office; and Dubai, one of the region's major business centres. Both Emirates are home to key investors in NSW including the Abu Dhabi Investment Authority, Emirates Group and DP World.

The priority sectors selected for this visit were infrastructure/construction, financial services, education and NSW food product exports. These sectors were chosen because they:

- all align closely with both UAE and NSW economic development priorities
- offer strong two-way trade and investment opportunities
- are sectors which are inter-linked.

The UAE program was an adjunct to the Premier's larger community visit to Lebanon. The NSW delegation accompanying the Premier to UAE was therefore limited to two Department of Premier and Cabinet staff and the participating Lebanese community leaders. No NSW business leaders participated in the visit to the UAE.

KEY OUTCOMES

- 1. Abu Dhabi Investment Authority: The Premier updated ADIA on key infrastructure investment opportunities in NSW and encouraged further investments by ADIA in NSW. ADIA is very interested in the opportunities to be profiled in the soon-to-be-released NSW Infrastructure Strategy.
- 2. Pacific Controls Systems: The Premier met with the company chairman and confirmed the ICT firm's plan of establishing a 24x7global command control centre in Sydney that will create jobs, drive innovation and foster research and development in NSW.
- 3. UAE airlines: The Premier discussed with key executives of the main UAE-based carriers the potential to increase in services to Sydney Airport and initiatives to help grow the market.
- 4. UAE Minister of State: The Premier and HE Reem Al-Hashimy discussed the UAE bid to host World Expo 2020 and the high level of specialised skills and experience NSW could provide to assist with the bid and the organising should the UAE bid be successful.
- 5. University of Wollongong in Dubai (UOWD): Premier officially opened Teaching Block 14 at UOWD at a ribbon-cutting ceremony and delivered an address to highlight the link between education, service exports and business investment. At this event the Premier also met with influential membership of the Australian Business Council Dubai and Australian Business Group, Abu Dhabi, where he communicated key areas of opportunity for growth between UAE and NSW.
- 6. Islamic Finance Round Table: the Premier met with key senior UAE finance specialists and discussed the potential of Islamic finance in NSW. The Premier reconfirmed his commitment to attracting both conventional and Islamic finance investment into infrastructure and other sectors in NSW, and as an important part of the NSW Government's efforts to enhance Sydney's position as a leading international financial services centre.
- 7. Milk & Honey: The Premier officially opened a new retail outlet which distributes a range of NSW gourmet food items in one of Dubai's prestigious residential areas. Milk & Honey stocks quality products from 14 separate NSW exporters and the NSW Government continues to provide information on new potential suppliers from the State. Milk & Honey have indicated increased interest and demand as a result of the visit has sparked their interest in investigating the possible establishment of a trading office in NSW.
- Dubai International Finance Centre (DIFC) NSW partnership: NSW and DIFC signed an MOU which recognises that Sydney and Dubai have common interests, expertise and objectives, and which will further support the promotion of unexplored investment opportunities between NSW and the GCC region among potential investors from both sides. NSW is the only Australian State to have such an agreement.
- 9. High level government to government meetings were held with HE Sheikha Lubna Al Qasimi, Minister of Foreign Trade and HE Sheikha Reem Al-Hashimy, Minister of

State, where the Premier reiterated the strong ties between the two governments. The Minister accompanied a trade delegation to Sydney in June where the Premier and NSW were able to provide hospitality, industry briefings and other assistance to a range of UAE businesses.

- 10. A meeting was also held with HH Sheikh Ahmed bin Saeed Al Maktoum (son of former Emir of Dubai and uncle of the current ruler of Dubai), President of the Department of Civil Aviation, CEO and Chairman of The Emirates Group and Chairman of Dubai World.
- 11. The mission and key NSW messages were profiled eight times in six separate business media outlets in the UAE.
