TRADE AND INVESTMENT MISSION TO CHINA AND HONG KONG SAR BY THE HONOURABLE BARRY O'FARRELL MP PREMIER OF NEW SOUTH WALES 1 – 8 JUNE 2013

POST VISIT REPORT

MISSION PURPOSE

- Continue to demonstrate the NSW Government's commitment that the State is open and ready for business with China, Australia's largest bilateral trading partner.
- Reinforce existing government and business relationships, in particular to form relationships with new high level government officials.
- Promote NSW strengths and capabilities to secure trade and investment outcomes, including:
 - Promoting Sydney as Australia's leading financial services centre
 - Advancing Sydney's case as the natural home for a centre for Renminbi settlement, and
 - Promoting new investment opportunities in infrastructure and property.
- Discuss the upcoming 25th NSW-Guangdong Joint Economic Meeting to be held in Sydney with business, government and academic leaders.
- Increase awareness of NSW Government Trade & Investment Offices in Guangzhou and Shanghai and the services they offer in supporting inward investors and helping to globalise NSW companies.

MISSION DESCRIPTION

This was the Premier's third mission to China as Premier. This was the Premier's first international mission aligned to the new approach of high level meetings as outlined in the NSW International Engagement Strategy.

The Premier's visit program consisted of six high level government meetings, seven key business meetings and seven business events across four cities and over five days (a program summary is attached to this report).

Cities and Rationale

- 1. <u>Hong Kong</u>: current offshore Renminbi trading hub and leading financial services centre.
 - Gain an understanding of the opportunities following the April 2013 agreement on direct conversion of the Australian dollar and the Renminbi
 - Promote Sydney's ideal position as an international trading hub for the Renminbi, and
 - Hold meetings with current and prospective investors, government and Australian business community in Hong Kong.
- 2. Guangzhou: capital of Guangdong Province, NSW's Sister State of 34 years.
 - Recruit high level commitment from government and industry to participate in the 25th NSW-Guangdong Joint Economic Meeting in Sydney
 - Reinforce and refresh deeper relationships with Guangdong corporate and government partners.

- 3. Beijing: national capital and seat of government.
 - Engage with the newly installed Central Government.
 - Sign the NSW-Beijing Metropolitan Memorandum of Understanding (MOU), under-pinning the 2012 Sister State Relationship Agreement.
 - Reinforce the message that NSW is open and ready for business, with a multi-billion dollar pipeline of infrastructure projects and broader opportunities well-aligned with the interests of Chinese investors.
 - Meetings with state-owned enterprises, including investors of Chinese foreign exchange, and build on relationships developed from previous missions.

4. Shanghai: China's mainland financial capital.

- Speak with financial services sector leaders regarding the opportunities following the April 2013 agreement on direct conversion of the Australian dollar and the Renminbi.
- Promote Sydney's ideal position as an international Renminbi trading hub.
- Reinforce relationships formed with the Shanghai Metropolitan Government through existing friendship agreement.

KEY OUTCOMES

- Premier signed an MOU with the Beijing Metropolitan Government, following the establishment of a NSW-Beijing Metropolitan Sister State Relationship in 2012. Areas of activities include culture, economy and trade, education, science and technology, and sport.
- 2. Premier addressed high-level audiences including Asia Society, Advance, investors, Chinese banks and business round tables to:
 - Outline NSW's ongoing engagement with Asia
 - Promote NSW's economic strengths and diversity
 - Identify NSW infrastructure investment opportunities, and
 - Raise the profile of NSW as an attractive investment destination and trading partner.
- 3. Premier strengthened the 34-year NSW-Guangdong Sister State Relationship, and held high level discussions with key corporate and government audiences regarding the 25th Guangdong-NSW Joint Economic Meeting to be held in Sydney.
- 4. Premier promoted Sydney as a leading international financial services centre, and outlined NSW's competitive advantages and the opportunities arising from the internationalisation of the Renminbi, including profiling Sydney as being uniquely positioned as a future Renminbi trading hub.
- 5. Premier met with senior members of provincial governments and the new Central Government strengthening these key relationships and reinforcing NSW's commitment to continuous engagement with this priority market.
- 6. Premier participated in a 20 minute interview by GDTV focusing on the NSW-Guangdong Sister State Relationship, Guangdong's oldest agreement of its kind.
