MISSION TO THE REPUBLIC OF KOREA, MALAYSIA AND SINGAPORE BY THE HONOURABLE VICTOR DOMINELLO MP MINISTER FOR INNOVATION AND BETTER REGULATION 3-11 OCTOBER 2015 MISSION REPORT

MISSION PURPOSE

The Republic of Korea, Malaysia and Singapore are considered leaders for digital innovation. The purpose of the Minister's visit was to investigate approaches to digital innovation, the collaborative economy, data analytics and digital government initiatives in those jurisdictions whilst promoting the work of the NSW Government in relation to digital innovation (including data analytics). The Republic of Korea, Malaysia and Singapore are all identified as priority markets in the *NSW International Engagement Strategy*.

This Mission sought to obtain first hand advice from Government representatives, industry experts, research institutions and policy makers that will help inform the NSW Government's approach to the innovation portfolio.

KEY OUTCOMES

1. Promoted NSW Government initiatives in digital government and data analytics and generated interest in investment opportunities in NSW

3. Identified opportunities for NSW

The Minister has identified a number of opportunities for the NSW Government to:

- Foster the growth of the digital ecosystem, including data analytics initiatives in NSW
- Increase engagement/collaborative with innovative/digital businesses
- Take advantage of our location, strong economy and reputation to leverage commercial opportunities and exchanges with other jurisdictions
- Position NSW as a leader in relation to digital innovation
